In addition, CCS conducts marine plastic research and a robust marine debris recovery program and does extensive public education for K-gray audiences. CCS' marine disentanglement program provides local marine mammal and sea turtle rescue and informs international groups through equipment provision and training. CCS' operates exhibit space and two seasonal retail establishments.
